The field in question has Alpha-Numeric characters in the Field, yet only Alpha or Numeric characters are allowed, but not both types of characters. For the Field in question, check the Field Type column in Chapters 5 and 6 of the current MAT Guide for more information. Also, Chapter 2, Section 2.6.1 of the current MAT Guide explains Data Format Standards for Fields in TRACS files.

"TRANSMISSION REJECTED: MIXED TENANT AND VOUCHER RECORDS IN MATHR BATCH"

Condition: See NOTES.

NOTES: This Error is no longer being generated by TRACS.

Z "A MANDATORY FIELD MUST NOT BE ZERO OR SPACE FILLED"

Condition: See NOTES.

NOTES: The information provided with this Message identifies the location of the Field Number and Field Content that needs to be corrected before the TRACS file can be resubmitted. Check the Note column in Chapters 5 and 6 of the current MAT Guide. Any Field that has an "M" in the Note column requires that Field to be filled in with valid values or codes as listed in the Definitions and Edits column for that Field. A Mandatory (M) field cannot be space filled or filled in with zeros. Also, Chapter 2, Section 2.6.1 of the current MAT Guide explains Data Format Standards for Fields in TRACS files.
