RBD FASTFacts - HUD Forms OMB Approval Numbers and OMB Expiration Dates



There have been many changes to the HUD forms posted on HUD's HUDClips web site at www.hud.gov/forms. HUD has also provided clarification regarding the requirement to include OMB approval numbers and OMB expiration dates.

It is important that everyone is familiar with the rules surrounding inclusion of OMB approval numbers and expiration dates. There are two key definitions:

1. Forms generated from HUDClips
2. Forms generated using TRACS or site software

A HUD Clips form is a form that is generated when an owner/agent goes in to HUDClips from their computer and either prints a hard copy of the form directly from HUDClips and writing or typing in the information required to be filled in by the owner/agent or using the form fillable document on HUDClips (when available). These forms must include all OMB information:

- OMB Approval Number (top right)
- OMB Expiration Date (top right)
- Form Number (lower right)
- Approval Date (lower right)
- Language supporting the Public Reporting Burden (bottom of form)

A form generated using site or TRACS software is a HUDClips form that includes the same language, but is generated from the site's TRACS software, such as Yardi Voyager or RealPage OneSite. The form can also be generated using other site software such as Microsoft Word or Adobe Acrobat.

These forms should be presented with form numbers, OMB approval numbers, OMB approval dates and language explaining the Public Reporting Burden as indicated in HUD's Forms Requirements Matrix located on the HUD RHIP web site at https://www.hud.gov/sites/documents/DOC_20481.PDF. You should always check the matrix to determine if HUD has provided permission to remove the expiration dates when these forms are generated by site or TRACS software.

We have updated the information to include the latest version of the forms.
